

# Clinical Tutors in Medicine and Surgery (two posts)

#### **FURTHER PARTICULARS**

# St Edmund Hall, Oxford

St Edmund Hall invites applications for two Clinical Tutors, one in Medicine and one in Surgery, to commence from October 2025 (or as soon as possible thereafter). Each post is tenable for a fixed term of two years in the first instance.

# **Background**

St Edmund Hall has a thriving medical sciences community of both pre-clinical and clinical Medicine students and currently admits five to six students per year for the pre-clinical course and typically has around 12 students on course during the clinical years (Years 4–6). Teaching and academic support for Medicine students at the Hall is provided by a small group of Fellows and non-stipendiary lecturers.

#### **Overview**

The purpose of these new posts is to support the teaching of the Hall's undergraduate clinical Medicine students, while also fostering the academic and professional development of the postholders. The appointments would be suited to clinically qualified individuals at senior specialist trainee or consultant grade with an interest and experience in medical education, who wish to expand their teaching portfolio.

# **Duties and Responsibilities**

The principal duty of each appointee will be to provide **teaching and academic support** to St Edmund Hall's clinical Medicine students. This will include:

- Delivering tutorials or small-group teaching sessions in either Medicine or Surgery (to Year 4 or 6 students), depending on the field of specialisation of the postholder. It is anticipated that each fellow will deliver on average approximately one hour of teaching each week.
- Assisting with organisation of teaching and mock examinations, where appropriate.
- Contributing more broadly to the life of the medical sciences community of the Hall.

These posts are supported by the Specialists in Global Health (SiGH) Foundation (<a href="https://www.sigh.global/who-we-are">https://www.sigh.global/who-we-are</a>) and therefore an interest also in global health education which will support the strengthening of connections with clinicians overseas is desirable.

## **Person Specification**

Applicants should:

- Be medically qualified, ideally at the level of senior specialist trainee (ST6+) or consultant with either MRCS or MRCP.
- Have experience and understanding of undergraduate teaching and training within the Oxford context.
- Have an understanding and commitment to welfare and mentoring of Medicine students.
- Have an interest in global health medical education (desirable).

### **Stipend and Benefits**

Postholders will receive an annual stipend of £2,500. There will also be an entitlement to 30 lunches per year and one dinner per week during full term at St Edmund Hall, when the college kitchen is open.

#### **Tenure**

These are fixed-term appointments, tenable for **two years**, subject to satisfactory performance.

#### **Application Process**

Applicants should submit:

- 1. A curriculum vitae.
- 2. A statement (maximum two pages) outlining their reasons for application and relevant teaching experience.
- 3. Names and contact details of two referees.
